### MEMORANDUM OF ASSOCIATION

OF

### SHREE TIRUPATI BALAJEE FIBC LIMITED

- I. The Name of the Company is SHREE TIRUPATI BALAJEE FIBC LIMITED\*
- II. The Registered Office of the Company will be situated in the State of Madhya Pradesh.
- III. The objects for which the Company is established are as under:

# 3. (A) THE MAIN OBJECTS OF THE COMPANY TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:

1. To carry on the business of producers, manufacture, by sell, export, import, process, convert, laminate reprocess or therwise deal in FIBC (Flexible Intermediate Bulk Containers)/ Jumboo Bags, all kind of plastic woven sacks, polyethylene line gunny bags, yarn, laminating materials, resins, wax, any plastic items.

## 3. (B) MATTERS WHICH ARE NECESSARY FOR FURTHERANCE OF THE OBJECTS SPECIFIED IN CLAUSE 3(A) ARE:

- 1. To acquire and take over the whole or any part of the business property and liabilities of any person or persons, firms or corporation carrying on any business which the Company is authorised to carry on or possessed of any property or rights suitable for the purposes of the Company.
- 2. To apply for, purchase or otherwise acquire any patents, brevets, invention, licenses concessions and the like conferring an exclusive or non-exclusive or limited right to use any secret or other information as to any invention which may seem capable of being used for any of the purposes of the Company or the acquisition of which may seem calculated directly or indirectly to benefit this Company and to use, exercise, develop grant, licences in respect of or otherwise turn to account the property right and information so acquired.
- 3. To enter into any partnership or any arrangement for sharing profits, union of interest, joint adventure, reciprocal concession or therwise with any individual, firm or company carrying on or engaged in or about to carry on or engage in any business or enterprise which the company is authorised to carry on or engage in any business or transaction capable of being conducted so as directly or indirectly to benefit this Company and or take of otherwise acquire and hold share or stock in or securities of and to subsidies or otherwise assist any such Company and to sell, hold, reissue, with or without guarantee or otherwise deal with the same.
- 4. To enter into any arrangement with any Government or authorities supreme, municipal, local or otherwise that may seem conclusive to the Company's objects or any of them and to obtain from any such Government or authority, any right, privileges and concessions which the Company may think fit desirable to obtain and carry out exercise and comply with any such arrangements, rights, privileges and concessions.

- 5. From time to time subscribe render services to any charitable, benevolent or useful object of a public character including exhibition the support of which will in the opinion of the Company tend to increase its repute or popularity among its employees, its customers, of the public, to give pension, gratuities or charitable aid to person or persons who have served the Company or to the wives, children or other relatives of such persons and to form and contribute to Provident and benefit of any person engaged by the Company.
- 6. To sell, dispose or mortgage, exchange, lease or transfer the business property and undertaking of the company or any part thereof for any lawful consideration which the Company may deem fit to accept and particular by shares fully or partly paid up, debentures, debenture stock, bonds or securities of any other Company and/or to promote any Company or companies for the purpose of acquiring all or any of the properties rights and liabilities for this Company or any other purposes which may seem directly or indirectly calculated to benefit this Company.
- 7. To purchase, or take on lease or exchange, hire or otherwise acquire any real and personal property and right and privileges, which Company may think necessary or convenient for the purpose of its business and in particular purchase any land, building construction, basement's machinery, plant stock in trade.
- 8. To invest surplus money of any which the Company not required immediately in any form of investment including shares, stocks, bonds, debentures, obligations or other securities of any Company or association or in Government securities or in deposit with Bank or Banks as may be considered desirable and from time to time to vary such investment.
- 9. Subject to the provisions of the Company Act, 1956 to lend money to such persons and on such terms and conditions as may seem expedient with or without security and in particular to customers and other having dealings with the Company and to give any guarantee or indemnity as may seem expedient. But the Company will not do banking business as defined under the Banking Regulations Act, 1949.
- 10. Subject to the provisions of Section 58A and other relevant sections of the Companies Act, 1956 and rules made thereunder and Directives of Reserve Bank of India to receive money on deposit with or without allowances of interest, to borrow or raise money with or without security and/or secure the payment of money by mortgage or by the issue of bond mortgages, hypothecation, lien or any other security founded or based or charged upon all or any of the property or rights of the Company or in such other manner as the Company shall think fit and for the purposes aforesaid to charge all or any of the Company's property or assets movables or immovable liquid or otherwise present and future, including its uncalled capital and collaterally or further to secure any securities of the Company by a trust deed or other assurance and to redeem, purchase or pay off any such security, provided that the Company shall not do banking business as defined in the Banking Regulations Act, 1949.
- 11. To open account with any banks and/or financial institutions and to draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, hundies, bills of lending warrants, debentures and other negotiable instrument subject to Reserve Bank of India's Directives.
- 12. To adopt such lawful means of making known the productions of the Company as may seem expedient and in particular by advertising in the press, by circular, by purchases and exhibition of work of art or interest by publication of book and periodicals and by granting prizes rewards and donation, but the Company shall not make any political donation.

- 13. To establish and maintain local registers, agencies and branch places of business and to procure the company to be registered or recognized and carry on business in any part of the world, subject to law in force.
- 14. To sell, improve, manage, develop, exchange, enfranchise lease, mortgage, dispose off, turn to account otherwise deal with all or any part of the property and rights of the Company.
- 15. To pay for any right of property acquired by the Company and to remunerate any person, firm or body corporate rendering services to the company either by cash payment or by allotment to him or them shares or securities of the Company, paid up in part or otherwise.
- 16. To pay out the funds of the Company all expenses of and incidental to the formation, registration, advertisements and establishments of the Company.
- 17. Subject to the provisions of the Companies Act, 1956 to distribute as bonus shares amongst the members or reserve or otherwise apply as the Company may from time to time determine any money received in payment of dividends accrued on forfeited shares and money realized from the sale by the Company of the forfeited shares or any money received by way of premium on shares or debentures issued at a premium by the Company to invest any surplus money of the Company in such investments (including shares of stock in the Company) as may be thought proper and to hold, sell or otherwise deal with such investment.
- 18. Subject to the provisions of Section 293-A of the Companies Act, 1956 to subscribe otherwise to assist or to guarantee money to charitable, benevolent, religious, scientific national, public or other institution or objects which shall have any moral or other claims to support or aid by the Company either by reasons of locality of operations or of public general utility.

### (C) OTHER OBJECTS ARE

- 1. To carry on the business as manufactures, buyers, sellers, importers, exporters, agents, fitters, installers, assemblers of and dealers in all types of machineries equipments, components, tolls and spares of compresses.
- 2. To carry on the business of iron masters, forgers, iron founders, -mechanical and electrical engineers, steel and nom-ferrous metal convertors, manufacturers of agricultural implements and manufacturers on machines and tools, brass foundersi metal workers, boiler makers and metallurgists.
- 3. To purchase, take On lease or otherwise any mines, mining rights and to acquire Certificate of approval iron the Union of India and any interest therein, and to prospect, explore, work, exercise, develop and turn to account same.
- 4. To construct, purchase or take on lease cinematography, theatres, cinema halls and other building and works convenient for the purpose thereof and to manage, maintain and carry such theatres and other buildings, when so erected on.
- 5. To carry on the business of manufacturer, purchaser, seller of bricks, tiles, wood works, cement empty cement bags, boards, plywood, aluminium and all other building materials.
- 6. To carry on the business of running motor lorries, motor taxis, motor mini buses and conveyances of all kinds and on such lines and routes as the Company may think fit and to transport passengers and generally to do the business of common carriers.
- 7. To establish and work cement factories and to carry on the business of cement, lime burners and ceramics including sanitary fitting and chinaware.



- 8. To cultivate, grow, produce, or deal in any agriculture, vegetable or fruit products and to carry on all or any of the business of farmers, dairymen, milk, contractors, dairy farmers and milk products, condensed milk and powdered milk and powdered milk, cream, cheese butter, poultry, fruits, fruit essences, vegetables, cash crops, and provisions of all kinds, growers of, and dealers in corn, hay and straw, seedsmen and nurserymen, all types of flower products, flowers essences and to buy, sell manufacture and trade in any goods usually traded in any of the above business or any other business inclusive of staple foods and medicinal preparation from milk, vegetables, flowers, and animal products or any substitute for any of them associated with the farming interests which may be advantageously carried on by the Company.
- 9. To carry on the business of manufacturers of or dealers in soap, cosmetics, perfumes and toilet requisite, pulp and paper of all kinds and articles made from paper or pulp and materials used in the manufacture or treatment of paper, including card board, mill boards, wall and ceiling papers and packaging cartons and newsprints and photographic raw films.
- 10. To carry on the business of manufacturers of or dealers in industrial machinery of all types including bearings, speed reduction units, pumps, machine tools and agricultural machinery and earth moving machinery including road rollers, bulldozers, dampers, loaders, shovels and drag lines and light engineering goods such as cycles and sewing machines and their components.
- 11. To carry on the business as manufacturers, dealers, stockists, exporters, and importers of bolts, nuts, and nails, hinges hooks and all other hardware items of all types and descriptions.
- 12. To carry on the business of manufacturers, dealers, exporters, Importers purchasers and sellers of MFG Films, Auxiliaries hosteleen, and ancillary items thereon.
- 13. To do all types of interior decoration work, repair; fabrication, processing work according to customer's specification in furnishing the buildings.
- 14. To carry on business or businesses of manufacturers, importers, exporters and dealers in sheets, metal (ferrous and non-ferrous) and sheet metal articles of all kinds in particular (i) alluminium and steel doors, windows, levers and automatic door closers, (ii) galvanished buckets; fire buckets, bath tubs, mugs, drums, tanks, tin containers and other articles for carrying or storing water oil and other solid or liquid materials (iii) all kinds of steel and metal furniture (iv) chimneys copes, ridgins, ventilators, roofings, hand carts, municipal carts and all other such articles.
- 15. To carry on business or businesses of manufacturers, importers and exporters and dealers in ferrous and non-ferrous-casting of all kinds and particular (i) pans, rice bowls, cooking pots and hollow-wares of all kinds (ii) cooking stoves of all -description and their accessories (iii) cast iron pipes and fittings railings,' stair cases, ventilators and all building materials, (iv) main hole covers, surface boxes, cisterns, weights and castings of all description big or small (v) mild and malleable castings, special alloy castings and foundry works of all kinds, (vi) forgings of mild carbon alloy stainless steel and forging of all types.
- 16. To carry on the business of garage keepers and suppliers in and dealers of petrol or other motive power to motors and other things.
- 17. To carry on the business of buying, selling exchanging, altering, importing, improving, assembling, distributing motor vehicles, trucks, tractors implements electrical goods, refrigerators, household and commercial appliances iron and steel furniture and other manufacturing's.

- 18. To carry on the business of manufacturers of and/or dealers in leather imitation leather, oil cloth, linoleum, tarpaulins and the like.
- 19. To carry on the business of manufacturers, purchasers, sellers, importers, exporters, and distributors of synthetic fiber yam fabrics, and man made fabrics.
- 20. To carry on the business of manufacturers, buyers, sellers, exporters contractor and dealers in Textile machinery, industrial Lubricants, chemicals and sizing material and all type of item required by Textile Industry.
- 21. To carry on the business of manufacturers, refiners, importers and exporters of and dealers and extracting oil merchants in Copra, cotton seed, linseed, castor seed Soyabeenseed, groundnut or any other nut or seed or oil bearing substances whatsoever and oils, cakes manufactured there from, manufacturers of cattle feed, edible flour nutritionates flectured food, protein, enriched food and fattening preparation of every description, maker and manufacturers of manners and fertilisers of every description and flour merchant.
- 22. To carry on the business in poultry of all kinds of breeders in livestock including cattle, cows, buffaloes pigs, sheep, goats mules and such other rearing, sheep farming livestock importers, exporters, agents in agricultural tools, devices, accessories, seeds, plants, manners, flowers, farming accessories, days, aromatic chemicals and to prepare, formulate, recipes of all such sorts would help as the business of Company.
- 23. To produce tea, coffee, rubber, cinchona and such other products.
- 24. To carry on the business as brewers, distillers and manufacturers of and merchants and dealers in wines, spirits, beer malts, grains, gases, fuels and energy and powers, materials of all kinds and descriptions seafood products to deal in all agricultural inputs such as implements, machinery fertilisers, pesticides, seeds and any other commodities and things.
- 25. To carry on the business of hotel, restaurant, flight kitchen, café, tavern, beer house, refreshment room and lodging house, proprietors, dramatic and musical, publishers and printers, theatrical agents, box office keepers, concert room proprietors, licensed victuallers, wine, beers and spirit merchant, brewers, masters, distillers and manufacturers of aerated mineral and artificial water and other drinks purveying caterers for public amusements generally and proprietors, job masters farmers, dairymen, poultryers, ice merchants, importers and brokers good of live and dead stock and colonial and hair dressers, perfumers, chemists proprietors of dubs, baths, dressings rooms, libraries, ground and Instruction of all kinds tobacco and cigar merchants, agents for railways and shipping companies carries, theatrical add opera box office proprietors, enterprises and general agents.
- 26. To carry on the business of manufacturers of bitumen, hussein based roofing felts, fiberglass issues, aluminium foils, fibres plastic or any articles or things.
- 27. To manufacture, process or sell low and high density polythene polypropylene high molecular, high density polythene film and bags and sheeting and lay flat tubings and or to convert any of the polythene polypropySenellM/FIDPE products into any size or shape for use in packing and wrapping of all varieties of goods and to print aft plastic, high density/low density polythene, polypropylene FIN1/1-1DPE products whether rigid or flexible for packing wrapping and for use as stationery articles, publicity and display and for daily domestic or commercial/industrial use.


28. To carry on the business of manufacturers, dealers, merchants, exporters, merchants agents in textile goods as whole-sellers, semi whole-sellers, retailers as also installation of power

looms and establishing process houses for bleaching dyeing, printing, calendering and other processing of textile goods and to act as commission agents.

- 29. To establish shopping markets, show rooms, nursing homes, schools, club houses cinemas, office premises and other building for commercial purposes on lands-seized and licensed basis.
- 30. To carry on the business as traders, dealers, wholesellers, retailers, scourers, spinners, weavers, finishers, dyears and manufacturers of yarn and fabrics of wool, cotton, silk, rayan, nylon terelyne and other natural synthetics, manufacturers of materials from the waste realised from the above mentioned product either on its own account or on commission and to carry on the business as drappers and dealers of furnishing fabrics in all its branches, as readymade dress and mental makers, silk sareemakers and suppliers, clothing, general drapeis, hosiery gloves, lace makers, leather dressers adn felt makers.
- 31. To carry on the business of Finance, Financiers, Promoters, Guarantors, Hire purchase Transactions, financing of hire purchase transaction and to finance directly or by way of leasing and or hire purchase finance to industrial enterprises/undertakings, by makeing advances or subscribing/investing to the share capital, providing seed capital and to finance for purchase of land, industrial sheds, buildings, machineries, plant, automobiles, truks, buses, jeeps, cars, lorries tractors and other industrial/consumer/household goods, items and for that purpose to receive money accept deposit/loans, to draw, accept, discount, endorse, acquire, sell purchase any negotiable or transferable securities as per RAIL Guidelines.
- 32. To carry on the business of transport of goods, animal or passenger from place to place either by air or by land or sea, partly through sea and partly by land or air, whether in air planes, motor vehicles, animal drawn vehicles, cycle, car, ships, bi-planes or in any other manner whatsoever and to carry on all or any of the business i.e. General carriers, transporters, railways and forwarding agents, warehouseman; store-keeper, bounded carmen and common carmen.
- 33. To carry on business as manufacturers of and dealers in coal, coke, coal-tar, carbon black of all kinds, natural and synthetic coal gas, fibres and films and all kinds of organic chemicals products.

- 35. To carry on the business of an estate and leasing Company.
- 36. To contract, carry out, maintain, improve, manage, work, gas, work electric works factories, warehouses and other works and conveniences which may seem directly or indirectly conclusive to any of the Company's object and to contribute, subside or otherwise assist or to take part in such maintenance, management working control superintendence.

- 39. To act as dealers whole-seller retailers, stockists consignments agent, commission agent, representative selling agent, purchasing agent distributors brokers exporters & importers.
- 40. To carry on the business of manufacturers, buyers, sellers, importers, exporters, hirers, assemblers and dealers in as original equipment manufacturers as also on a jobbing industry basis and in any other capacity every kind of machineries, component parts, replacement parts, spare parts, accessories assemblies, tools, implements and fitting of all kinds, ornamentation and decorative parts for motors, vehicles, trucks, tractors, motor lorries, motor-cycles, scooters, buses minibuses, locomotives, tanks, ships, engines, wagon's, boats, barges, launches, submarines, aeroplanes, airships, sea plances, baloons, aircrafts, spaceships, spacecrafts, rockets, spaceshuttles of every description and other and other vehicles.
- 41. To carry on the business of suppliers of plant, machinery and equipment stores, tools, gadgets, devices, contraptions, instruments, spares and components and to develop, acquire, supply plans, drawings estimates, projects reports and know-how for industries, business companies, services, and public bodies and Government.
- 42. To carry on in India or elsewhere the business to manufacture, produce, make, prepare, refine, mix, develop, buy, sell, resell, trade, build, process, extract, grow, cultivate, rear, breed, distribute, market, import, export, inter-port, research, invent, discover, acquire, barter, mine, option, exchange, forward, store dispose, handle manipulate, procure, supply, franchisee operation, selling agent appointment, internet based commerce, automated electronic vending machine operation, authorised dealership appontment, and to act as a wholesaler, retailer, supplier, indenter, bottler, packer, repacker, distiller, mover, preserver, merchant, consignment agent, jobber, marketman, middlemen, agent, C & F agent, distributors, sole-selling agent, dealer, deicredere agent, commission agent, underwriter, advisor, broker, representative, consultant, oollaborator, adatiya, stockiest, liaisoning agent, operator, job worker, contractor, arbitrator, organizer, market creator, or otherwise, to deal in all and every kind, description, variety, shape, size, colour, modiality, specification, packing and application of all types of goods, articles, commodities, construction & infrastructure materials, chemicals, drugs, pharmaceutical products, cosmetics, merchandise, agricultural produces, instruments, apparatus, machineries, spare parts, components, know-how, technology, trade marks, patents, software, hardware, used in general, human, medical, agriculture, construction horticulture, sericulture, industry, defense, aviation, navigation, entertainment, satellite, research, hospitals, hotels, advertising, education, computer, science, automobiles, geographical, domestic and other allied purpose.
- 43. To carry on the business of manufacturing, marketing and leasing computer word processors and other microprocessor based systems as well as the manufacture of software programmes for use with any of the above mentioned items.
- 44. To purchase, import, repair, of leather tanning machines, leather sewing and cutting, finishing machines, tools and implements.
- 45. To commence the business of trading and dealing in all types of shares, securities, bonds, debentures of any Company or Corporation including all types of Agri and Non-agri commodities, bullions, metals and such other units as are permitted for trade by any recognized stock and/or commodity exchange in India whether for cash, spot or with futures and options with or without delivery.
- 46. To carry on the business of manufacture, assemble, purchase, sell, import, export, and deal in tents, tent cloths, utensils crockery, curtains show pieces, decorative items, carpets,



pillows bed, covers, decorative lighting articles and all other allied articles in connection therewith.

- 47. To carry on the business of manufacturers of & dealers in surgical, scientific equipments, appliances.
- 48. To apply for and become in India or abroad member of any Stock Exchange, Securities and Exchange Board of India, Over the Counter Trading and Exchange of India, National Stock Exchange, Bombay Stock Exchange and any other similar stock exchange of the country recognised or to recognised, depository participates of any desposibory, and other authoribh body or institution, established or as may be established from time to time by Government, financial institutions, Board, or any other person or group or persons, and to act as advisor, broker, sub broker, remiser, market maker, representative, Sub-broker and to carry of any depository services, derivatives operations, and all incidental acts and things necessary for the attainment of foregoing objects.
- 49. To carry on the business of trading in agriculture products, metals including precious metals precious stones, diamonds petroleum and energy products and all other commodities and securities, in spot market and in futures and all ldnd of derivatives of all the above commodities and securities and further to canyon the business as brokers, sub-brokers, market makers, arbitrageurs, investors, and/or hedgers, in agricultural products, metals including precious metals, precious stones, diamonds, petroleum and energy products and all other commodities and securities, in spot markets, and in future and all kinds of derivatives of all the above commodities and securities permitted under the laws of India and for above purpose, to become members and participate in trading, settlement and other activities of commodity exchangels (including national multi-commodity exchange/s) facilitating, for itself or for clients, trade and clearing/settlement of trade in spot, in futures and in derivatives of all the above commodities permitted under the laws of India.
- 50. To carry on business as Broker In Stock and Securities, future and option trading, investors, derivatives traders, consultants in capital market and ffnancial investment, merchant banking in all its aspects, to act as issue house, registrars to issue, transfer agent, depository participant, to acquire and hold one or more membership in stock/security exchanges, trade associations, commodity exchanges, clearing houses or association or otherwise in India or any part of the world.


